**ORDINANCE 2024-**

**AN ORDINANCE AMENDING  
THE BUDGET FOR FISCAL YEAR 2023**

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

**WHEREAS**, the budget for the Water Fund will spend more funds than was appropriated by Ordinance 2022-12, and;

**WHEREAS**, corporate authorities desire to increase the Water Fund Temporary Salaries, R/M Vehicles, R/M System, Contractual Services, Printing and Publication, Water Purchases, Small Equipment, and Meters line items by \$252,720 and increase the funds appropriated by Ordinance 2022-12, and;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:**

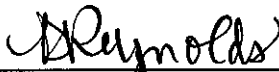
**Section 1:** That total expenditures appropriated for the Water Fund will be increased from \$1,941,500 to \$2,194,220 for Fiscal Year 2023.

**Section 2:** Ordinance No. 2022-12 is hereby amended.


**Section 3:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

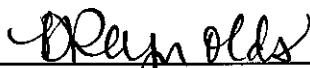
