## ORDINANCE NO. 2017- 6

## ORDINANCE AMENDING CHAPTER 71 – TRAFFIC SCHEDULES IN THE CODE OF ORDINANCES FOR THE VILLAGE OF MT. ZION, ILLINOIS

WHEREAS, the Village of Mt. Zion, Illinois, has the lawful authority under the provisions of Illinois Compiled Statutes, 625 ILCS 5/11-208, to enact various traffic regulations within the Village, and

WHEREAS, the Village of Mt. Zion, Illinois, has heretofore adopted Ordinances directing traffic on intersecting streets to stop or yield the right-of-way.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Schedule I – Stop Streets shall be amended to include stop signs on Henderson Street at Fletcher Park Blvd. creating an all-way stop.

SECTION 2: That staff is hereby directed to cause the appropriate traffic signs giving notice of such Stop Intersection be erected at the intersection of such streets as specified in Section 1 of this Ordinance after the end of the 2016-2017 school year. The Stop Intersection, as designated by this Ordinance, shall become effective when such signs are so erected.

SECTION 3: This Ordinance shall be in effect 10 days after its passage, approval and publication. The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.
