ORDINANCE 2018-6

AN ORDINANCE AMENDING CHAPTER 71 – TRAFFIC SCHEDULES – SECTION V: PARKING CODE OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS CODE OF ORDINANCES

WHEREAS, parking may be prohibited in the Village of Mt. Zion pursuant to Section 70.10 PARKING PROHIBITED, when signs are erected to give notice that parking is prohibited; and

WHEREAS, the Village Board of Trustees desire to control parking on the north side of Spitler Park Plaza Drive between State Highway 121 and Douglas Drive;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Parking is hereby prohibited on the north side of Spitler Park Plaza Drive between State Highway 121 and Douglas Drive.

SECTION 2: Signs shall be erected giving notice, that no person shall park a vehicle, trailer or any other piece of equipment at any time on the above mentioned street or portions of street described above.

SECTION 3: When signs are erected giving notice, no person shall park a vehicle, trailer or any other piece of equipment upon the street described above for any purpose or period of time other than loading or unloading passengers, not to exceed 5 minutes at any place.

SECTION 4: Any person who owns and/or operates a vehicle, trailer or other piece of equipment in violation of the provisions of this ordinance shall be subject to penalties of the provisions of Section 70.99 Penalties of the Mt. Zion Code of Ordinances

SECTION 5: This ordinance shall be in full force and effect from and after its passage and publication as required by law.
