ORDINANCE NO. 2019-7

**AN ORDINANCE TO VACATE A PORTION OF
A DEDICATED STREET THAT IS NO LONGER USEFUL BY THE
VILLAGE OF MT. ZION**

**BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE
OF MT. ZION, MACON COUNTY, ILLINOIS AS FOLLOWS:**

WHEREAS, the Board of Trustees of the Village of Mt. Zion, Illinois, is of the opinion that the portion of the dedicated Street described above and depicted on Exhibit "A" attached to this Ordinance shall be vacated and therefore it is not in the best interest of the Village of Mt. Zion, Illinois to retain title to said street;

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF
THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS:**

Section 1. That Street depicted on Exhibit "A" shall be vacated.

Section 2. That the Board of Trustees have opted to waive any claim for compensation by vacating said street.

Section 3. That as a result of this vacation, the following property owners shall become the owner of the parcel described below:

- A. The owner of the property commonly known as 800 Westside Drive, Mt. Zion, IL 62549; Tax ID: 12-17-04-154-004 shall become the owner of the parcel described as Parcel 1 on Page 2 of Exhibit "A."
- B. The owner of the property commonly known as 1210 Sunnycrest Drive, Mt. Zion, IL 62549; Tax ID: 12-17-24-154-006 shall become the owner of the parcel described as Parcel 2 on Page 3 of Exhibit "A."
- C. The owner of the property commonly known as 1220 W. Main Street, Mt. Zion, IL 62549; Tax ID: 12-17-04-302-001 shall become the owner of the parcel described as Parcel 3 on Page 3 of Exhibit "A."

Section 4. At least fifteen (15) days prior to the Village Board Meeting that was held to vacate this property, a Notice was published in a newspaper of general circulation which serves the Village of Mt. Zion, Macon County, Illinois.

Section 5. That following the passage of this Ordinance, the Ordinance shall be published in a newspaper of general circulation which services the Village of Mt. Zion, Macon County, Illinois.
