BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1:

SECTION 2: The Village shall provide term life insurance coverage in an amount not to exceed \$50,000 for each full-time employee and elected official.


SECTION 3: Ordinance No. 2019-26 is hereby repealed.

SECTION 4: This Ordinance will be in full force and effect upon passage, approval and publication as required by law.


