

ORDINANCE NO. 2022-6

ORDINANCE AMENDING CHAPTER 51 WASTEWATER SERVICE
CHARGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 52.10 Wastewater Service Charges shall be amended to read as follows:

- I. **Basic User Charge:** There shall be and there is hereby established beginning June 1, 2022, a basic user charge of \$2.30 per 1,000 gallons of metered water consumption to be applied to all users to recover O, M & R costs. An additional 3% annual (June 1st) increase will be added at the beginning of each fiscal year.
- J. **Unit Service Charge:** There shall be and there is hereby established an administrative service charge of \$2.75 per month to each separate residential, commercial, or industrial user of the wastewater facilities attributed to the cost of readings, billings, and administration.
- K. **Capital Improvement Charge:** There shall be and there is hereby established a capital improvement charge of \$0.55 per 1,000 gallons to each user of the wastewater facilities.
- L. **Sanitary District of Decatur Treatment Charge:** There shall be and there is hereby established beginning June 1, 2022, a Sanitary District of Decatur treatment charge of \$2.35 per 1,000 gallons to each user of the wastewater facilities for all users except "Special Users." An additional annual increase (June 1st) will be added at the beginning of each fiscal year to recover cost increases from the Sanitary District of Decatur.
- M. **Sanitary District of Decatur Treatment Charge for Special Users:** There shall be and there is hereby established beginning June 1, 2022, a Sanitary District of Decatur treatment charge of \$5.91 per 1,000 gallons to each Special User of the wastewater

facilities. An additional annual increase (June 1st) will be added at the beginning of each fiscal year to recover cost increases from the Sanitary District of Decatur.

N. All non-metered residential users of the wastewater facilities shall pay a flat rate charge of \$30.00 per month.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage, approval, and publications as by required by law.






