## **ORDINANCE 2025-22**

## AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR 2025

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

**WHEREAS**, the 2024 G.O. Capital Project Fund's fund balance is more than sufficient and exceeds expenditures to-date, and;

**WHEREAS**, the corporate authorities desire to fully expend the funds earned from interest income on a capital improvement project, and;

**WHEREAS**, the corporate authorities desire to increase the 2024 G.O. Capital Project Fund – System Improvements and the line item by \$1,670 and increase the funds appropriated by Ordinance 2024-29, and;

**WHEREAS**, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the 2024 G.O. Capital Project Fund by \$1,670 to \$ 129,670;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**Section 1**: That total expenditures appropriated for the 2024 G.O. Capital Project Fund will be increased from \$128,000 to \$129,670 for Fiscal Year 2025.

Section 2: Ordinance No. 2024-29 is hereby amended.

**Section 3**: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
