## **ORDINANCE 2025-26**

## AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED FOR THE YEAR TO PAY DEBT SERVICE ON \$2,166,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE) OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS

**WHEREAS,** the President and Board of Trustees (the "Board") of the Village of Mt. Zion, Macon County, Illinois (the "Village"), by ordinance adopted on the 15th day of August, 2016, (the "ordinance"), did provide for the issue of \$2,166,000 General Obligation Bonds (Alternate Revenue Source) (the "Bonds), and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

**WHEREAS**, the Village has or will have Pledged Revenue (as defined in the Ordinance) available for the purpose of paying debt service on the Bonds heretofore imposed by the 2025 levy; and

**WHEREAS**, it is necessary and in the best interest of the Village that the tax heretofore levied for the year 2025 to pay the Bonds be abated;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:** Abatement of Tax. The tax heretofore levied for the year 2025 in the Ordinance is hereby abated in its entirety.

**SECTION 2:** Filing the Ordinance. Forthwith upon the adoption of this Ordinance, the Village Clerk of the Village of Mt. Zion shall file a certified copy hereof with the County Clerk of Macon County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2024 in accordance with the provisions hereof.

**SECTION 3:** This Ordinance shall be in full force and effect forthwith upon its adoption and approval as provided by law.
