The Village Of Mt. Zion will receive sealed bids at the Village Hall, located at 1400 Mt. Zion Parkway, Mt. Zion, IL 62549 for the construction of Village of Mt. Zion Florian Ave. Rehabilitation until Monday, September 20, 2021, 1:30pm. All bids will be publicly opened and read aloud at that time.

The work for which bids are asked includes the following:

Roadway reconstruction, approximately 1,250 lf along Florian Ave. between Baltimore Ave. and Nolan Ave., and approximately 120 lf along Nolan Ave north of Florian Ave. in Mt. Zion, IL. Milling and delivery of approximately 5"-7" depth of existing HMA roadway surface, excavation and disposal of approximately 6" depth of existing sub-base earth, and construction of new roadway consisting of geotextile fabric, 8" depth CA-5 base course and 4" depth of HMA surface course (in 2 courses).

Milling and overlaying approximately 3" depth of HMA surface course, and delivery of millings to Mt. Zion Public Works, approximately 1,070 lf along the multi-use trail running along Baltimore Ave in Mt. Zion, IL.

Delivery of all HMA millings to Mt. Zion public works.

The anticipated substantial completion date is November 15, 2021 and final completion date is November 30, 2021.
